UC Davis proposes to construct additional teaching and research greenhouses on approximately 5 acres. The project includes three main components: Cacao Germplasm Greenhouses (approximately 20,826 square feet of greenhouse space, Phase 1 Greenhouses Expansion (approximately 10,800 square feet of greenhouse space), and Future Expansion Area (approximately 34,800 square feet of greenhouse space). As new greenhouses are constructed in phases, existing greenhouses totaling approximately 53,250 square feet on 7.8 acres at the Orchard Park Greenhouses site would gradually be removed. The project includes related site improvements.
